**O R D E R**

Under the authority of Government letter NO.EDN.171/94/25 dt. 30.3.'96, and under the same principles and Conditions laid down by Government, regarding payment of Grant-in-aid, the Undersigned hereby sanction grant-in-aid to the Principal Nongstein College *with effect from* 1.4.'96 subjects to the fulfilments of Rules under deficit grant-in-aid and the following conditions :

(a) The approval of sanctioned posts as on 1.4.96 are as follows :-

**Scale of Pay**

1. Principal	- one post	- Rs. 3700-5700/- PM
2. Lecturers	- <i>seven</i> posts	- Rs. 2200-4000/- PM
3. U.D.A.	- one post	- Rs. 1375-2390/- PM
4. L.D.A.	- two posts	- Rs. 1050-1735/- PM
5. Lib.Assis- tant	- one post	- Rs. 1200-1995/- PM
6. Grade IV	- one post	- Rs. 820-1175/- PM
7. Chowkidar	- one post	- Rs. 820-1175/- PM

(b) That 40% of monthly fee income of the College be set apart for fee remission, buildings, repairs, libraries, equipments and Contingencies etc. At least five free studentship shall be granted on merit on the result of periodical examination.

(c) No full time or part-time lecturers shall be entertained without prior approval of the Director of Public Instruction, Meghalaya.

(d) No teacher in the College shall take more than one, shift for which prior approval of the Director of Public Instruction shall be obtained.

(e) No employee of the College shall accept any other employment connected with his College work without prior approval of the Director of Public Instruction, Meghalaya irrespective of such office being honorary or paid.

(f) The Principal and other Staff of the College shall not engaged themselves in activities detrimental to the educational interest of the Institution and which tend directly or indirectly to be subversive of Government.



(g) The grant will be liable to be withdrawn if -

(i) The percentage of pass from the College in the University Examination fall below the University average for three consecutive years.

(ii) Discipline is not properly maintained in College.

(iii) If there is violation of any of the conditions of the grants.

(h) (i) No person over 60 years of age shall be retained in the teaching staff, without approval of the Government.

(ii) The college shall be concluded in accordance to the statutes framed under the University Act.

The College shall abide by the Rules and Regulations laid down in the Education Department Rules and orders. The Assam aided College employees Rules, 1960, Rules regarding conduct and discipline of the Employees of Aided Educational Institution with leave Rules annexed there under the Assam Educational Department Rules and Orders 1930 as adopted by the Government of Meghalaya and Meghalaya Aided College Employees Death-Cum Retirement Gratuity Scheme, 1985.
