I am to convey the decision of the 105th Academic Council vide Resolution No.AC:105:2020:5:7:(i) held on 10th December, 2020 which resolved grant of renewal of Provisional Affiliation for B.Sc. (Hons) in Chemistry, Physics, Botany, Zoology, Mathematics, Biochemistry and B. Com (Hons) courses for a period of 3 (three) years w.e.f. academic sessions 2020-21 to 2022-23 in continuation to the Affiliation granted vide this office letter of even Nos. 224 and 225 dated 19/07/2019.

The College is required to fulfil the following conditions as laid down by the Inspection Team, and report back to the University:

- 1. The College needs to appoint at least 5(five) regular and qualified teaching faculty as per UGC/NEHU regulations in each the above mentioned Departments within the period of next one year and intimate the Director, College Development Council (CDC) about the recruitment.
- 2. All laboratories need to be updated with required tools and instruments to be able to take care of the practical syllabi. Departments of Zoology and Botany may think of strengthening their specimen collections.

3. The College library should acquire more text books (latest editions) and additional journals.

4. The College library needs to procure a set of Dewey Decimal Classification Scheme (latest edition) at the earliest.

5. Boys' and Girls' common rooms should be immediately re-created.

- 6. The College staff room needs to be extended in order to have sufficient space to accommodate all teachers.
- 7. The College should increase the number of reference books and new editions of text books need to be added in the Library. College should also add some UGC Care journals in the Library.

8. The College needs to install fire extinguishers in the Library.

9. All toilets need to have door stoppers and frosted glasses on the windows.

10. Emergency exits of the College are needed in each of the building.

- 11. The College should have separate toilet and washrooms for girls and boys and made functional at the earliest.
- 12. The College should make construction of ramps in the building for physically challenged person.
